KEY BENEFITS:

- Sharpes Rabbit pellets are a complete feed suitable for young growing and breeding rabbits.
- A high-quality feed formulated with quality ingredients, to provide an excellent source of protein and fibre to promote healthy growth.

BAG SIZES: 10kg, 20kg, 1/2 tonne or 1 tonne bags.

INGREDIENTS SELECTED FROM: Locally sourced Grains and Cereals, Plant Proteins, Limestone, Molasses, Macro and Trace Minerals & Vitamins and coccidiostat.

FEED RECOMMENDATIONS:

MEAT RABBITS	Introduce gradually from two weeks of age then feed ad lib until 5 days prior to slaughter.
BREEDERS	Restrict feed to 80-100gm/day after 8 weeks of age.
PREGNANT	Restrict feed to 115gms/day until the last week of pregnancy, thereafter ad lib until litter has been weaned.
LACTATING DOES	Ad-lib from last week of pregnancy until weaning (150- 250g depending on the litter size).
BUCKS	Up to 120gms/day

Sharpes rabbit pellets should be supplemented with hay to add variety to diet and to reduce the risk of obesity.

TOP TIP: Always ensure that rabbits have access to fresh, clean water.

TYPICAL ANALYSIS (approximate on an as fed basis):

Crude Protein 16.0% Crude Fibre 14%

STORAGE: To maintain quality please store product in a cool, dry and vermin free environment. Best fed within six months of production.
