### **WARNING CONTAINS RUMENSIN™ 20% MILLMIX™**

**For Animal Treatment Only.**

This feed contains Rumensin™ 20% Millmix™ in the lamb feed at a rate of 0.5 kg premix per tonne of feed as an aid in the prevention and control of coccidiosis caused by Eimeria bovis and Eimeria zuernii. This is the equivalent of 100 ppm (mg/kg) of monensin active ingredient in the lamb feed.

Rumensin™ 20% MillMix™ is a registered pursuant to the ACVM Act 1997, A009107. See [www.nzfsa.govt.nz/acvm](http://www.nzfsa.govt.nz/acvm) for registration conditions.
